SCHT TRUSTEE APPLICANT PRIVACY NOTICE

Data Controller:

Stirling City Heritage Trust (SCHT), Ground Floor, Cameron House, Forthside Way, Stirling, FK8 1QZ

As part of any recruitment process, SCHT collects and processes personal data relating to applicants. SCHT is committed to being transparent about how it collects and uses that data and to meeting its data protection obligations.

What information does SCHT collect?

The organisation collects a range of information about you. This may include:

- your name, address and contact details, including email address and telephone number;
- details of your qualifications, skills, experience and employment history;
- information about your current level of remuneration, including benefit entitlements;
- whether or not you have a disability for which the organisation needs to make reasonable adjustments during the recruitment process;
- information about your entitlement to work in the UK; and
- equal opportunities monitoring information, including information about your ethnic origin, sexual orientation, health and religion or belief.

SCHT may collect this information in a variety of ways. For example, data might be contained in application forms, CVs or resumes, obtained from your passport or other identity documents, or collected through interviews or other forms of assessment [including online tests].

SCHT may also collect personal data about you from third parties, such as references. SCHT will only seek information from third parties with your permission and will inform you that it is doing so.

Data will be stored in a range of different places, including on your application record, in HR management systems and on other IT systems (including email).

Why does the organisation process personal data?

SCHT needs to process data to take steps at your request on commencement of the Trustee recruitment process. SCHT may also need to process your data to enter into a contract with you.

SCHT has a legitimate interest in processing personal data during the Trustee recruitment process and for keeping records of the process. Processing data from applicants allows the organisation to manage the recruitment process, assess and confirm a candidate's suitability and decide to whom to offer a Trustee position. SCHT may also need to process data from applicants to respond to and defend against legal claims.

SCHT may process information about whether or not applicants are disabled to make reasonable adjustments for candidates who have a disability. This is to carry out its obligations and exercise specific rights in relation to employment law.

For some roles, SCHT is obliged to seek information about criminal convictions and offences. Where the organisation seeks this information, it does so because it is necessary for it to carry out its obligations and exercise specific rights in relation to employment law.

If your application is unsuccessful, SCHT may keep your personal data on file for a maximum period of two years as detailed below. This is in case there are future Trustee opportunities arising for which you may be suited. SCHT will ask for your consent before it keeps your data for this purpose and you are free to withdraw your consent at any time.

The organisation will not use your data for any purpose other than the Trustee recruitment exercise for which you have applied.

Who has access to data?

Your information may be shared internally within SCHT for the purposes of the recruitment exercise. This includes the Trust Manager and the Office Manager for any data administration on behalf of the Trust Manager.

Additionally, your information may be shared with any members of our SCHT Board involved in the selection and interview process.

SCHT will not share your data with any other third parties other than those detailed above, unless your application for Trustee appointment is successful and it makes you an offer to join our Board of Trustees. SCHT will then share your data to effect the necessary appointment as a Director with Companies House.

SCHT will not transfer your data outside the European Economic Area.

How does SCHT protect data?

SCHT takes the security of your data seriously. It has internal policies and controls in place to ensure that your data is not lost, accidentally destroyed, misused or disclosed, and is not accessed except by our employees in the proper performance of their duties.

For how long does SCHT keep data?

If your application is unsuccessful, SCHT will hold your data on file for one year after the end of the relevant recruitment process. If you agree to allow the organisation to keep your personal data on file, SCHT will hold your data on file for a further one year for consideration for any future Trustee opportunities. At the end of that period, or once you withdraw your consent, your data will be deleted or destroyed.

If your application to join our Board is successful, personal data gathered during the recruitment process will be transferred to your confidential Trustee file [and retained during your tenure with us]. The periods for which your data will be held will be provided to you in a new privacy notice.

Your rights

As a data subject, you have a number of rights. You can:

- To be informed of the personal data we hold on you
- access and obtain a copy of your data on request;
- require the organisation to change incorrect or incomplete data;
- require the organisation to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing; and
- object to the processing of your data where the organisation is relying on its legitimate interests as the legal ground for processing.
- request personal data portability.

What if you do not provide personal data?

You are under no statutory or contractual obligation to provide data to SCHT during the recruitment process. However, if you do not provide the information, the organisation may not be able to process your application properly or at all.

Automated decision-making

Recruitment processes are not based solely on automated decision-making.
